SUMMARY

Offer Price and net proceeds from the Share Offer

- The Offer Price is HK\$0.52 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.52 per Offer Share, the net proceeds from the Share Offer to be received by the Company, before exercise of the Over-allotment Option, and after deducting the underwriting commissions and other estimated expenses payable by the Company in relation to the Share Offer, is estimated to be approximately HK\$86.9 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net proceeds from the Share Offer” below.

Applications under the Public Offer

- A total of 15,227 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 6,941,160,000 Public Offer Shares, equivalent to approximately 308.5 times of the total number of 22,500,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedure as disclosed in the section headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus has been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 100 times of the number of Offer Shares initially available under the Public Offer, a total of 90,000,000 Placing Shares have been reallocated from the Placing to the Public Offer. The final number of Offer Shares under the Public Offer is 112,500,000 Offer Shares, representing 50% of the total number of Offer Shares initially available under the Share Offer (assuming the Over-allotment Option is not exercised).

The Placing

- The Offer Shares offered under the Placing have been slightly over-subscribed which is equivalent to approximately 1.40 times of the total number of 202,500,000 Placing Shares initially available for Placing. The final number of Offer Shares allocated to 155 places under the Placing comprises 146,250,000 Offer Shares, representing 50% of the total number of Offer Shares initially available under the Share Offer (assuming the Over-allotment option is not exercised) and an over-allocation of 33,750,000 Shares. A total of 63 places have been allotted five board lots Placing Shares or less, representing approximately 40.65% of total number of places under the Placing. A total of 894,000 Placing Shares have been allotted to these 63 places, representing approximately 0.61% of 146,250,000 Shares (comprising 112,500,000 Offer Shares under the Placing tranche and an over-allocation of 33,750,000 Shares).

- The Directors confirm that no Offer Shares under the Placing have been allocated to any core connected persons (as defined in the Listing Rules) of the Company, including, without limitation, any Directors, existing beneficial owners of the Shares and any of the Company's subsidiaries or any of their respective close associates (within the meaning of the Listing Rules), whether in their own name or through nominees.
