There were no restrictions on any Shareholders to cast votes on any of the proposed resolutions at the 2023 AGM as set out in Rule 13.40 of the Listing Rules, and no Shareholder was required under the Listing Rules to abstain from voting in respect of the proposed resolutions at the 2023 AGM. None of the Shareholders have stated their intention in the Circular to vote against or to abstain from voting on any of the proposed resolutions at the 2023 AGM.

Tricor Investor Services Limited, the Company’s branch share registrar and transfer office in Hong Kong, was appointed as the scrutineer for the vote-taking at the 2023 AGM.

Mr. Li Cheuk Kam, Mr. Li Wai Fong, Mr. Wong Chik Kong, Mr. Chan Chung Kik, Lewis and Mr. Lee Kwok Lun, Directors of the Company attended the 2023 AGM in person.
